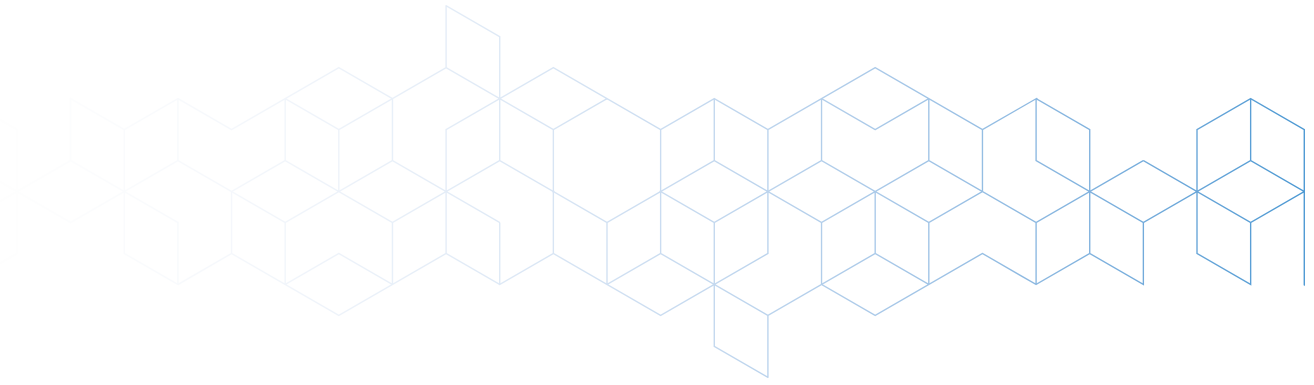

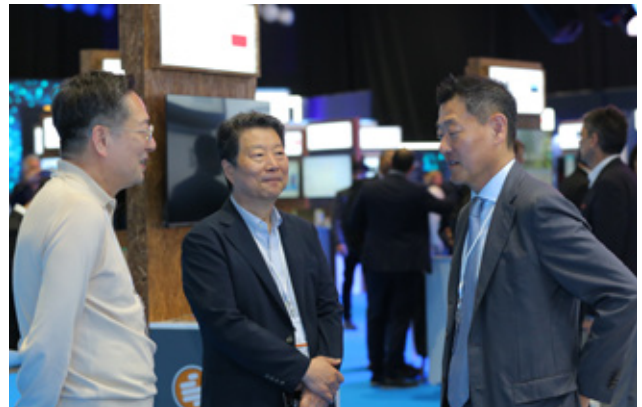

The keynote speech was delivered by the President of CCI Russia, Mr. Sergey Katyrin. The session was moderated by the Vice-President of CCI Russia, Mr. Dmitry Kurochkin.

At the Russia Investment Forum, Dr. Elena Faizrahmanova showcased Tatarstan's strong investment climate and the creation of Innopolis, a business-focused city. Eugene Borisoff highlighted the importance of innovation and technology transfer for economic growth, proposing Abu Dhabi as a potential global tech hub. Andrei Shestakov presented investment opportunities in Tula, focusing on projects like smart roads and thermoelectric modules. Bogoslovskaya Marina discussed unique tourism experiences in Yakutia, including hunting and gastronomic tourism despite the cold climate. The forum aimed to enhance international cooperation and investment, featuring keynote remarks from Sergey Katyrin, President of CCI Russia, and moderation by Vice-President Dmitry Kurochkin.

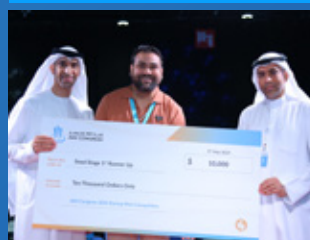

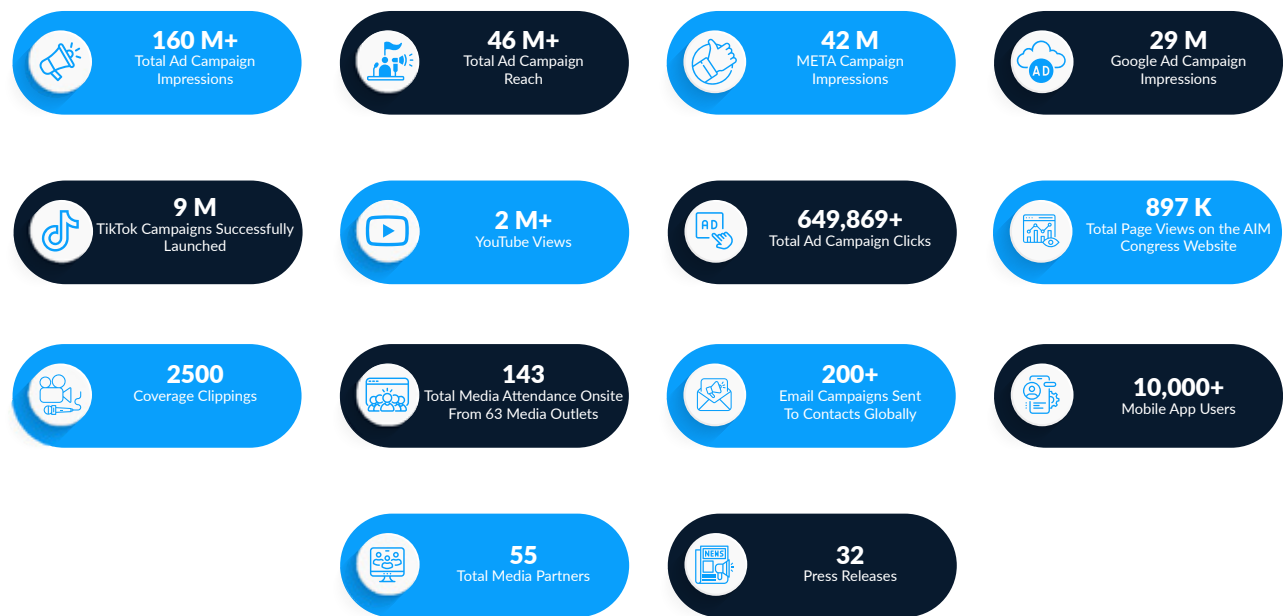
